

## Release and Waiver of Liability

This release and waiver of liability (the "Release") executed on the date indicated below by the registrant, (the "participant") in favor of the Metanoia Center whose business office is located at 316 Home Ave., Lockland, OH, 45215, whose building locations are 113 N. Wayne Ave and 115 N. Wayne Ave, Lockland, OH, 45215 and their partner organizations, and their board, directors, officers, employees, participants, and agents (collectively, "Releasees").



The Participant desires to participate in an event and/or class offered by or through the Metanoia Center and engage in the activities related to being a participant. The Participant understands that the activities may include, but are not exclusive to physical activities of lifting, carrying and so forth. The Participant does hereby freely, and without duress, execute this Release under the following terms:

1. **Waiver and Release.** The Participant does hereby release and forever discharge and hold harmless Releasees and their successors and assigns from all liability, claims, and demands of whatever nature, either in law or in equity, which arise or may hereafter arise from the Participant's activity related to the Metanoia Center. The Participant understands and acknowledges that this Release discharges the Releasees from any liability or claim that the Participant may have against any of them with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Participant's participation, whether or not any such liability is attributable to the absence of ordinary or even slight care by the Releasees arising out of participation.
2. **Medical Treatment.** Except as otherwise agreed to by the Metanoia Center and their partner organizations, their board, directors, officers, employees, participants, and agents, the Participant does hereby release and forever discharge all of them from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Participant's participation.
3. **Assumption of the Risk.** The Participant understands that participation may include activities that may be hazardous to the Participant, including, but not limited to, construction, loading and unloading, and transportation to and from the location. In connection thereto, the Participant recognizes and understands that activities at the Metanoia Center, in some situations, may involve inherently dangerous activities. The Participant hereby expressly and specifically always assumes the risk of injury or harm and releases the Releasees from all liability for injury, illness, death, or property damage resulting from the activities of the Participant, whether or not any such liability is attributable to the absence of ordinary or even slight care by the Releasees arising out of the Project.
4. **Insurance.** The Participant understands that, except as otherwise agreed to by the Metanoia Center and their partner organizations, their board, directors, officers, employees, participants, and agents, the Releasees may not carry or maintain health, medical, or disability insurance coverage for any Participant. Each Participant is expected and encouraged to arrive with medical or health insurance coverage in effect.
5. **Photographic Release.** The Participant gives the Releasees and any person acting under their

authority permission to publish, distribute, broadcast, televise, promote, license, sell and copyright for all purposes, any photograph, videotape, motion picture or sound recording produced directly by any of them or under their sponsorship, which may include my image or likeness and/or my voice. In addition, I authorize the use of any printed material in connection therewith. I release all claims against the Releasees with respect to copyright ownership, publication and right to privacy. I agree that I shall not receive any fee and that all rights, title, and interest to the above materials and use of them belong to the Releasees. I understand and agree that these materials may be duplicated or distributed with or without charge, and/or altered in any form or manner without future/further compensation or liability, in perpetuity.

6. **Other.** Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Ohio, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Ohio. Participant agrees that if any clause or provision of this Release shall be held to be invalid by any court or competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

**Duration.** This release and waiver shall be in effect for the current year of being signed until such a time that the Participant revokes it, and with the provision, that if not revoked, that it automatically renews from activity to activity within the year of signing.
